OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

This DEWALT FLEXVOLT® Cordless Hammerdrill & Impact Driver Kit Giveaway (“Giveaway”) is sponsored by DEWALT Industrial Tool Co., 701 E. Joppa Road, Towson, MD 21286 (“Sponsor”). The entry period will start on June 24, 2019 at 9:00 AM Eastern Time (“ET”) and end on July 1, 2019 at 11:59:59 PM ET (“Entry Period”). Pancake Laboratories, Inc.’s clock is the official Giveaway timekeeper. By entering this Giveaway, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and decisions of Sponsor which shall be final and legally binding in all respects. Each entrant understands that they are providing their information to Sponsor and the information provided will be used in accordance with Sponsor’s privacy policy (<http://www.dewalt.com/en-us/legal/privacy-policy>). Should there be conflict between Sponsor’s privacy policy and these Official Rules, these Official Rules shall govern. If an entrant does not fully agree to the terms of the Privacy Policy, such entrant should not enter this Giveaway. Any personally identifiable information collected during an entrant’s entry in this Giveaway will be collected by Sponsor or its designee and used by Sponsor and/or its designees for purposes of the proper administration, fulfillment, publicizing and promotion of this Giveaway as described in these Official Rules, as stated in Sponsor’s privacy policy or as otherwise expressly consented to by entrant during any separate opt-in opportunity provided to entrant during this Giveaway. All entries are the property of Sponsor and will not be acknowledged or returned. **Each entrant may enter this Giveaway a maximum of one (1) time per calendar day during the Entry Period using either of the methods below.** If an entrant enters more than once via the Product Review Entry Method during the Entry Period, each Product Review must be about a different DEWALT product that they own. One (1) Winner will be declared, and one (1) prize will be awarded. This Giveaway is subject to federal, state and local laws and regulations.

1. ELIGIBILITY: This Giveaway is open only to persons who are USA legal residents (50 states or Wash., DC) and age 18 or older at the time of entry. ANY ENTRY THAT PROMOTES ANY RECKLESS OR UNSAFE BEHAVIOR OF A DEWALT PRODUCT OR DOES NOT COMPLY WITH DEWALT PRODUCT OPERATING INSTRUCTIONS, IN SPONSOR’S SOLE AND ABSOLUTE DISCRETION, WILL REMOVED FROM THE WEBSITE AND DISQUALIFIED AS AN ENTRY IN THIS GIVEAWAY. Entries will also be disqualified if they contain any inappropriate or offensive language (in Sponsor’s sole discretion), do not provide an honest product review, violate any third parties’ rights, or include any comments about competitive products and/or pricing.

The opt-in to receive promotional emails from DEWALT is optional and you may unsubscribe at any time.

Each eligible entry entered during the Entry Period is herein referred to as an “Entry.” By entering this Giveaway, each entrant represents and warrants that his/her Entry is original, he/she owns all right and title thereto, and his/her Entry does not infringe any third party intellectual property rights. Entrants agree to assign and hereby do assign to Sponsor the ownership rights to all Entries. Once an entrant submits an Entry, the Entrant cannot change or delete it. Entries will be reviewed for content by Sponsor and Sponsor reserves the right to remove any Entry, in its sole and absolute discretion where such entry contains any inappropriate or offensive language (in Sponsor’s sole discretion), does not provide an honest product review, violates any third parties’ rights, or includes any

comments about competitive products and/or pricing.
